Te Kupenga poster competition

Te Kupenga Whakaoti Mahi Patunga, are also launching a poster competition to coincide with the conference. The competition is open to organisations, researchers and collaborations working in the family violence prevention and intervention space.

It provides an opportunity to showcase innovative initiatives, best practices in service delivery, insightful research findings and useful resources relevant to specialist family violence sector kaimahi. New Facilitators and Police Vetting

Providers have advised us of ongoing recruitment so we would like to take this opportunity to clarify and remind you about Police vetting as part of the new staff onboarding process.

To provide a better understanding of the vetting process we have created a document (attached in the email) outlining how to utilise the police vetting system to access and record the checks required for the facilitator approvals process. The document also clarifies the requirements of the Children's Act 2014 in regard to police vetting and safety checking of facilitators.

Providers will choose from two options when they're requesting a vetting check:

- '*Agency name*' (Select this option when requesting a vetting check for any staff who will not be facilitating programmes), or
- '*Agency name – Family Violence Specialists*' (Select this option when requesting a vetting check for programme facilitators and restorative justice facilitators).

Privacy Assessments

As you are aware, the Privacy Act 2020 requires providers to complete an annual data security self-assessment checklist.

This checklist is to help you meet the Privacy Act requirements and better understand if your systems are fit for purpose as you regularly deal with clients' sensitive and personal information. Agencies can use the self-assessment checklist to develop plans to address any gaps that are discovered.

We understand that system changes can take time and resourcing, and the Ministry does not require that all the recommended controls are in place immediately, but we do expect the privacy assessment to be reviewed and completed annually and for organisations to have reasonable systems in place to protect client privacy.

Entry to Expert (E2E) and Specialist Organisational Standards (SOS) Family Violence Capability Frameworks

Firstly, we'd like to acknowledge the contribution of family violence service providers and the wider specialist family violence sector, who helped to create these frameworks that were launched in May 2022. We know that many of your organisations already have these frameworks embedded into your organisational standards and worker capabilities. Thank you for your ongoing commitment to align with these frameworks. We encourage any who have not yet achieved this goal to work towards this end in achievable steps, and also to please let us know if you have any ideas about how the Ministry might be able to support your organisation to do this.

At the same time, the Ministry is working towards implementing these frameworks as they relate to non-specialists, for our own workforce and the wider courts workforce, under [Te Aorerekura Actions 11 and 15](#). Our priority is FVSV response training for the court workforce, which includes all frontline Ministry employees. Thank you to all of you who took the time to respond to our Request for Information about establishing a national infrastructure to deliver the FVSV response training to the court-related workforce. We will let you know when a Request for Proposals to establish this infrastructure is published on GETS early this year.

Quarterly Bulk-Funding Invoices

For those providers who are receiving bulk funding, your Quarter 3 bulk funding invoice can be submitted now. The payment will cover services from January to March 2023.

Bulk funding invoices can be submitted from the month prior to each new quarter, i.e., from December 1st for the quarter two period (January - March).

Fail to Attend sessions

We have had a few questions about the limits applicable for claiming failure to attend a session. We want to clarify, the total number of failures to attend a booked individual session that may be claimed is two per participant (not including support sessions). Some flexibility may be allowed if the participant is unable to attend due to Covid-19 related reasons.

Te Pae Oranga Whānau Pilot

As some of you may already be aware, New Zealand Police are piloting an initiative called Te Pae Oranga Whānau in 6 sites across the country. Te Pae Oranga whānau pilot will leverage from the successful Te Pae Oranga model to contribute to the vision of Te Aorerekura to eliminate Family Violence, by providing an alternative pathway for whānau and families to engage.

Te Pae Oranga whānau will enable our Iwi partners and panel providers to work with suitable family harm cases in ways that promote whānau healing and involve whānau as decision-makers in developing collective whānau plans for accessing the support and services they need. It is an opportunity for prevention; reducing future demand by working with at-risk whānau in ways that are whānau strengthening.

For a family harm case to be referred to Te Pae Oranga Whānau it has to meet eligibility criteria and get through of the steps of a multi layered decision process. Victim safety is central to this process.

The pilot commenced in November 2022 and will end in February 2024, with learnings and finetuning occurring alongside continuous evaluation. Next steps will be decided after findings and recommendations are completed at the end of the pilot.
